## **IN PRACTICE**


The Glebe Youth Service is primarily funded by Community Services (formerly DoCS) and the City of Sydney, with a number of other small grants and fundraising received for specific programs.

The GYS runs a range of programs for young people aged 12-24 years old who live, work or play in the Glebe area.

The primary target for our programs are the young, disadvantaged people living within the Glebe Estate, a Housing NSW area that covers most of the lower half of Glebe.

These young people face a range of issues including poverty, family dysfunction, alcohol and other drug use, chronic school refusal and poor literacy leading to unemployment.

The majority of young people who use the service are Indigenous, with the attendant disadvantages of poor health, educational issues, over-representation within the legal system and other factors of social disadvantage.

# CHAIRPERSON'S REPORT

The Glebe Youth Service Inc. acknowledges the traditional owners of this land, the Gadigal Peoples of the Eora Nation.

Welcome to the Glebe Youth Service Inc 2009-2010 annual report.

This, the 22nd year of the GYS, has been a very transitional year. We have seen significant changes starting with the resignation of our Coordinator, Colin Stokes. After six years of dedicated and hardworking service, Colin decided to move on. For the GYS, Colin's six years has been a very healthy tenure. Colin has significantly enhanced existing service relationships and has developed and grown relationships with new community partners, programs and funding bodies significantly over the last six years.

We were very sad to see Colin leave, but sincerely thank him for his dedicated work at the service and within the Glebe community. We wish him the very best with his future endeavours and look forward to his ongoing involvement and support through the community sector organisation he now works alongside.

Upon Colin's resignation, we began a recruitment drive for a new Coordinator. The position attracted a lot of interest from many qualified candidates. We were pleased to engage the services of Leichhardt Councillor, Darcy Byrne, as the new Coordinator. Unfortunately for the GYS, Darcy was only with us briefly before moving on to pursue a full-time career in politics. We look forward to continuing our relationship with Darcy in his new role.

The GYS in-house staff promptly filled in by taking on additional duties, thus ensuring ongoing quality of service to the young people and wider Glebe community. Senior Youth Worker, Keiran Kevans, stepped into the position of Acting Coordinator with verve and has conducted the service admirably during this period. All other GYS staff stepped up to the plate to keep the doors open, thus minimising the number of closures. This is a truly remarkable achievement, which evidences the high level of teamwork of GYS staff and their commitment to the service.

Locating a permanent, full-time Coordinator has taken longer than initially anticipated. Consequently, this transitional phase has impeded the service's strategic planning and development for 2009-2010, as it has been difficult to make plans without a permanent, full-time Coordinator in place. The Management Committee is working to resolve this situation and we believe we will have a long-term solution in place very soon.

Keiran has managed to keep all of the programs on track and indeed moving forward during this difficult period. The Glebe Pathways Program, sponsored in partnership by the Department of Education and Training, the University of Sydney and Save the Children Australia, has experienced its own unique challenges this past year. Keiran, along with the help of the Management Committee, particularly Roelof Smilde, has been developing groundwork for future directions for the program in consultation with our partners.

The Management Committee has also been active in keeping the organisation running on a day-to-day basis. As a result, the service has continued to move forward, despite staff changes and the service still being down one full-time Youth Worker for the previous four years. In particular, we have been focusing on OH&S development and training, policies and procedures, and reporting methods for the service. As a result, the GYS has made some positive progress in each of these directions. Once again, we must thank our excellent workers who have kept all of our GYS programs running. The Management Committee and I wish to thank Senior Youth Workers, Ainsley Warner, and Keiran Kevans for stepping into the Acting Coordinator position under such difficult and challenging circumstances. Thanks to retired Coordinator, Colin Stokes, for his dedication to the service over the last six years. Big thanks go to Christina Yeomans, Financial Administrator, who has continued to grow and develop our administrative support and capacity at the GYS.

The Management Committee also says a big thanks to the casual pool; a group of individuals who bring to the service a great diversity of skills and strengths. Among those who have been involved in maintaining quality service delivery this past year include a team of casual staff members: Alex Keil, Anne White, Jacob Taylor, Kayla Graham, Kate Witherdin, Travis Lane, Ray Mason, Michael Carr, Nathan Katchwalla, Sophie Cuzilla, Stuart Barber, William Byrne, Dan Conway and Stephanie Deuchar. Further thanks are also extended to the many volunteers who contribute their time, energy and various skills to the GYS. The service is greatly appreciative of their support and involvement.

Once again, I would like to thank the GYS Management Committee for yet another remarkable year of solid work and growing commitment to the service. The Management Committee's support has been unwavering during this extended period of transition. The Management Committee's involvement with the day-to-day running of the service is at an all time twenty two year high; an incredible reflection of the dedicated individuals concerned.

My personal and continued thanks to Treasurer, Hilary Chesworth; Secretary, Jeremie Quiohilag; and general Management Committee members: Rosalind Hecker, Roelof Smilde, Patrick Cunningham and Joe Mannix. Thanks to our new members, Chantel Cotterell and Naomi Hart for their excellent contributions. Thanks to Nicole Harries, Adeline Chin and Corrado Ferraccioli from Broadway Shopping Centre for your involvement and valued input at our monthly meetings. We also extend a thank you to Fran Bickmore from Broadway Shopping Centre, who has also supported the service.

On behalf of the GYS, I would also like extend a thank you to City of Sydney for their ongoing support and contribution to the GYS. In particular, we appreciate the funding that the GYS has received from City of Sydney for the After Dark program. Helen Xiros and Leah Brown from the City of Sydney deserve a special mention for their support, advice and attendance at our monthly Management Committee meetings.

Special thanks also to the Becher Foundation for their support of the Year 10 program in 2009.

The next twelve months are going to be a very challenging period for the service. With the restructure of Community Services NSW (formerly DoCs), the GYS is going to see additional requirements for reporting and accountability. The GYS will need significant extra resources by way of real funding to be able to accommodate these changes. This will be the biggest challenge for GYS in 2011, however we are confident that we can meet these challenges.

# TREASURER'S REPORT



The financial reports for 2009-2010 have shown, once again, that our staff have an exceptional talent for making a small amount of money go a long way. We end the year with a surplus of \$1,978, bringing our total Equity to \$25,507. The surplus represents 0.5% of the total budget of \$380,000, which shows just how closely the service has monitored its expenditure.

The majority of our income came from Community Services NSW (\$227,985), which provides our core funding, and from the City of Sydney (\$150,000) which supports the After Dark program and casework services.

Financial assistance previously received from the Becher Foundation has been a tremendous assistance in supporting the Glebe Pathways Program, as it came to fruition this year.

Special thanks to Patrick Cunningham, a member of our Management Committee, for organising a fundraiser through Sydney Uni Boxing Club, and to Keiran Kevans for fundraising at the GYS Movie and Fun night held last December.

We also gratefully acknowledge donations from The Glebe Society and the Australia China Cultural Exchange Centre.

The coming year presents new challenges as Community Services NSW sets new criteria for funding youth organisations such as the GYS. The City of Sydney has agreed to fund After Dark for another two years, with a modest increase to cover rising costs. Our Acting Coordinator, Keiran Kevans, has already completed two applications for funding from different sources, in the hope that we may eventually have enough money to employ the extra Youth Worker that we so desperately need.

Our previous Coordinator, Colin Stokes, committed endless enthusiasm and effort in his six years at the Glebe Youth Service and made many improvements to the service.

Our current staff, Keiran, Ainsley Warner, Tegan Rowles and Christina Yeomans, continue to work collaboratively to produce far more than could be expected with such limited resources.

With these staff, we know that the Glebe Youth Service continues to be in good hands.

# COORDINATOR'S REPORT



Throughout the past twelve months, the Glebe Youth Service has experienced its share of highlights and challenges. In particular, we have experienced an increased demand for our programs and services, with group programs being well-attended and demand for case management consistently exceeding supply.

With Australian Bureau of Statistics data predicting a significant growth in the number of 12-24 year olds living in Glebe over the next five years, we anticipate that this demand will remain strong and continue to increase. In a sense, the GYS "punches above its weight" when one considers our modest annual budget and relatively low staff numbers, against the number of clients we serve, programs we operate, and the complexity and number of presenting issues.

The GYS relies heavily on our agency partnerships to realise our objectives and enhance our effectiveness. In order to best assist and advocate for young people within Glebe, it is imperative that we continue to nurture these agency partnerships, and also, explore new possibilities with government agencies, community organisations and corporate sponsors.

## FUNDING

The successful partnership between the GYS and the City of Sydney continued in 2009-2010, as evidenced by the GYS securing an additional two years of funding from the Community Service Grants Program. This is a wonderful result and my sincere thanks to Helen Xiros and Illana Kaplin for their guidance and support in managing the grant submission and also our ongoing relationship with the City of Sydney.

However, despite Glebe being acknowledged as a suburb where youth service gaps exist, the City of Sydney has indicated they are unprepared to fund the service beyond July 2012. This leaves the GYS with only a Coordinator and one Youth Worker, which is not a viable arrangement, considering the increasing demand for our programs and services. A carefully thought out strategic approach to this situation will be one of the many challenges we face in the coming year.

An additional challenge facing the GYS will be the realignment of the CSGP funding program by Community Services NSW. Whether this will introduce more funds into the sector remains to be seen, however one thing is clear, we are almost certainly going to face a narrowing of our service specifications and increased expectations on outcomes and reporting.

Staff will need to learn about new performancebased accountability reporting requirements. We will also need to focus on shorter term case plans and prioritise work with the 12-18 year old age group. Whilst the GYS acknowledges the importance of early intervention programs, we are concerned that this will detrimentally impact on service provision for 18-24 year olds.

Changes at both the state and local government level make it very clear that a focus on strategic planning and funding issues will be crucial in 2010-2011 in order to ensure we continue to realise our purpose to assist young people.

## **EDUCATION**

Another highlight for the year was the reestablishment of an education program based at the GYS. Throughout 2009, a committed group of staff and agency partners undertook a concerted effort to lobby for the necessary funds to provide high school education to those young people living in Glebe who have not successfully engaged with the mainstream system.

Initially a loose alliance between GYS personnel, academic staff from the University of Sydney's

Faculty of Education and Social Work and Ultimo TAFE Outreach Educationt, these partnerships became somewhat more formal when funding was sought and successfully obtained for the Glebe Pathways Program.

I wish to extend a special thanks to GYS Management Committee Member, Roelof Smilde; Deb Hayes from the University of Sydney's Faculty of Education and Social Work; Doreen Wilson and Paul Parkes from the NSW Department of Education and Training, and John Maynard from the City of Sydney.

The Glebe Pathways Program commenced teaching in Term 4, 2009. I am pleased to advise that you can read a detailed report about the program in this annual report.

### FAREWELL COLIN STOKES

This year saw the departure of Colin Stokes after six years of committed and loyal service. I worked with Colin for three and half of those years and I feel privileged to have been his colleague. Much of what I know about the GYS and the Glebe community I have learnt from Colin. His work on improving the safeness of the GYS environment, both physical and psychological, has been a huge achievement. It has certainly made the job of the new Coordinator easier, with less time devoted to managing challenging and unacceptable behaviour, and more time for administration, partnership management, volunteer management and strategic planning issues.

Colin's work in brokering and establishing the GYS partnership with Save the Children Australia must also certainly be counted as a highlight of 2009-2010. This partnership has resulted in Save the Children Australia funding a Pathways Education Support Worker. This is position is based at the GYS and has been a great addition to the service. As a testament to his good work on this partnership, Colin has been recruited by Save the Children Australia and we wish him the very best in his new role. It is also very pleasing that his work there has allowed the GYS to maintain a connection to Colin.

On behalf of all GYS stakeholders, I would like to formally thank Colin Stokes for his service to the GYS and the broader Glebe Community.

### SUMMARY

In 2009-2010, we have seen a growth in demand for the programs and services of the GYS. It has also seen the emergence of some "threats" or challenges to the ongoing viability of the service. The number of active partnerships and/ or collaborative programs has increased. This has been a great positive for the service. The GYS is firmly "rooted" in the Glebe community. We enjoy respect and appreciation from our service users and their families and also from the wider community. While demand for services continues to grow so should the diversity of ideas about how we manage, fund and operate the service.

In 2010-2011, it is very important that all stakeholders in the Glebe Youth Service work effectively and proactively together to explore new approaches to providing the services we do.

We have a wonderful Management Committee with a wide variety of professional skills and the necessary commitment to, and passion for, social justice values. We have a small but talented team of staff members, as well as a wonderful team of volunteers, network of service partners and supporters. If all of us can work together in the coming year, it will indeed be a good one.

# GYS PROGRAMS: CASEWORK

## THE YEAR IN REVIEW

The demand for casework services has grown steadily over the past twleve months. In the past year, thirty eight young people have sought some type of case management services. Some of these involve short term crisis interventions and/or referral, others medium to long term casework engagement and assistance.

Many clients are referred to other service providers for specialist services and referrals. These include, but are not limited to, health, education, supported housing, independent living, life skills training, counselling, vocational training and legal expertise.

Many young people come to us for a "crisis" intervention. We have been working hard over the past twelve months to move clients beyond crisis intervention toward medium and longer term casework engagement and personal goal setting. This is not always easy, but there have been some remarkable successes.

There is a well-established pathway to case work though our group programs such as Drop In and After Dark. Engagement, trust and rapportbuilding occurs in these programs. This is a necessary ingredient to a successful caseworkerclient relationship with our client group. Trust and engagement are valuable commodities!

The GYS also receives referrals from a variety of other services, government departments and NGOs. External referrals are received from, but not limited to: Juvenile Justice, Community Services NSW, High Schools, Police, Glebe Public School, Centipede (After Hours Care in Glebe), Barnardos, NSW Health and local community and family members.

Although there have been some wonderful success stories over year, the going is tough

and positive outcomes require a consistent and professional approach. Complex issues of social disadvantage that originate from entrenched intergenerational familial and social issues often require long term multiple service solutions. This is an ongoing and complex challenge. Notable and relevant to the GYS is the continuing poor social outcomes for Indigenous Australians. This group accounts for 85% of GYS case clients.

The substantial decrease in youth crime this year is a pleasing and welcome trend. This is a fact that has been verified by the Leichhardt Local Area Command. While Police claim that the decrease in crime is primarily due to prehearing bail conditions, such as curfews and suburb and street exclusions, there are also other possible reasons. In particular, one reason, is the hard work that the GYS has been putting into supporting personal growth and development of the service users. The GYS, through a range of programs, have encouraged young people to make healthy and sensible life choices.

## THE YEAR AHEAD

The realignment of the Community Services Grants Program, introduced by Community Services NSW, will no doubt have implications around the delivery and reporting of casework services delivered by the GYS. It is unclear, at this stage, what these implications will mean.

One thing we do know is that there will be a strong focus placed on "input" and "outcome" reporting and the pressure to close case files after arbitrary periods of time. It will be imperative, in the coming year, that we direct resources into improving casework data collection and management systems for reporting purposes.

The Australian Bureau of Statistics predicts significant growth in the number of 12-24 year olds living in Glebe in the coming year.

In Australia the gap between rich and poor continues to grow at an alarming rate. The logical extrapolation of these two facts is that demand for case management and youth services generally, will continue to grow. The challenge for the GYS is to respond, in line with our Constitutional objectives, and find creative solutions to fund and service this growing need.

# GYS PROGRAMS: DROP IN



The daily afternoon Drop In program was the first Glebe Youth Service program and continues to be the flagship of all our programs. The program operates from 3pm and 5pm on weekdays, providing a safe space for young people to socialise after school and engage in a number of creative and recreational activities. Everyday there is a nutritious meal served. Attendance has grown steadily throughout 2009-2010. We have consistently averaged in excess of thirty young people attending each Drop In.

Another interesting trend this year has been a rise in the percentage of young women accessing this program. The program attendance in 2010 was approximately 50% male and 50% female. This is no doubt in part due to the excellent work and engagement skills of Ainsley Warner.

Our Drop In program plays an essential role in the building of trust and rapport with our clients. It is also often the first point of contact between GYS staff and new young people.

There have been many highlights for Drop In this year. We are particularly excited at the success of some of our creative programs, which has led to some positive outcomes for our young people.

In Drop In this year we have painted murals, made individual art of all kinds, played cricket, table tennis, pool, basketball and hundreds of games of touch football. We have also discussed issues such as mental and sexual health along with crime and conflict. We have watched movies and made movies, learnt to act and cook and most importantly learnt to socialise with others in a positive way.

Over 100 individuals have come through our Drop In program this year. Whilst some of these only stayed for a brief period, approximately 60 have stayed on to form the core group of the service. These are the same young people that come to our holiday activities, our Glebe Pathways Program and invite us to help them through the obstacles they encounter.

The service remains committed to providing a recreational space for young people. In a society where youth are often confined to the home there are many healthy outcomes for young people who get out and about. The Drop In program provides a forum where hanging out with those of the same age is a healthy choice.

# GYS PROGRAMS: AFTER DARK

The After Dark program is an initiative of the Glebe Youth Service and funded by the City of Sydney. Implemented every Friday and Saturday night, from 7.30pm to 11.30pm, the After Dark program is held at the Peter Forsyth Auditorium each Friday and the GYS each Saturday. The program aims to provide a space for young people, aged 12-24 years old, from the local Glebe area, that is safe, enjoyable and provides structured recreational and education programs.

The After Dark program presents a diversity of recreational, creative and lifestyle activities, which aim to provide the young people with choices in regards to how they wish to spend their time at After Dark.

Over the previous year, implemented programs include: cooking, indoor soccer competitions, basketball, touch football, creative activities (e.g., painting, drawing and working with pastels), performances by Indigenous artists such as Radical Sun, movie nights, word games and puzzles and table tennis competitions. The GYS staff involved with the After Dark program understand that each young person is unique in regards to their interests, hence the wide range of available activities on offer.

At each and every After Dark, a nutritious meal is also cooked and served, often with the assistance of the young people.

The After Dark staff consists of a dedicated team of workers from a diversity of professional and personal backgrounds, including social workers, youth workers, artists, parents and local community members.

Both Indigenous and non-Indigenous workers are employed to staff the After Dark program, with the majority of staff having worked on the program for several years. Volunteers have also been involved in the program over the previous year, as well as regular visits from the Youth Liaison Officer from the Glebe Police.

In the instance where a young person is experiencing difficulties in their life, experienced staff are available for the young person to express their situation or issue. Where warranted these young people are referred to a caseworker at the Glebe Youth Service.

Several significant outcomes have resulted due to the existence of the After Dark program over the previous year. Such outcomes are inclusive of:

- The After Dark program has had 2992 attendances;
- Over 3000 meals have been provided to young people;
- 217 referrals have been made to relevant services and/or the Glebe Youth Service caseworkers;
- Communications with the Glebe Police has indicated that youth crime has decreased significantly within the Glebe area over the past year.

The After Dark program is greatly valued by the young people participating, the dedicated After Dark staff and the core staff at the Glebe Youth Service. The program is essential in positively contributing to the lives of the young people who participate in the wider Glebe community.



# GYS PROGRAMS: HOLIDAY ACTIVITIES

The Holiday Program at the Glebe Youth Service offers young people entertainment and positive experiences during their school holidays. A range of recreational activities are scheduled to give the young people an opportunity to enjoy themselves and to remain occupied and positively engaged.

Many of the young people would be unable to fund these activities for themselves and could become bored and inactive during this time.

The activities often involve travelling to different places and having new experiences, which is important for broadening their horizons and creating new interests. The activities offered are also an incentive for positive behaviour and a reward for getting through the school term. The young people are able to relax and have fun, which is something they are entitled to.

Furthermore, the Holiday Program is a great time for the development of positive relationships between young people and staff, as well as between young people themselves. The extended time spent together, positive experiences and also the challenges, helps create these important relationships and a sense of community.

The external activities that have been successful this year include movies, sports competitions, beach and barbeque days, as well as trips to the local pool. Extended Drop In times are also offered during the school holidays, where a meal is provided and activities are organised, such as ping pong competitions and movies.

The Holiday Program will also involve at least one special activity that requires further funds and is something for the young people to look forward to. This year we have taken excited groups of around fifteen young people to Luna Park, Jamberoo, and laser tag. The Holiday Program continues to be a popular and valuable program, and is important for encouraging the engagement of young people with the GYS.

# GYS PROGRAMS: CAMPS

## BACKGROUND

The Kalandan Foundation, a Public Benevolent Institution, was established by Greg Powell as a means to professionally, strategically and financially operate programs to assist both marginalised youth and wild horses. The name of this program... is called Brumby Camp. Greg has operated the Brumby Camp since 2004 with a community service organisation.

By bringing both horses and young people together Greg believed that a formed partnership and connection between the two could be a gateway for change for young, marginalised youth. In Greg's experience, through the process of developing a meaningful partnership with a horse, people learn to appreciate self, and expand their confidence and ability in other areas of life. Learning about the engagement process with an animal and self through the utilisation of respectful practices, Greg believed that youth would be able to transfer these learnings and skills to engage in a positive way with others. Therefore. it became Greg's vision to assist young people to work through problematic behaviour via a program that promotes kindness, patience, persistence and consistency to assist in a shared transformation of both parties.

## THE CAMP

After a long period of negotiation and discussion with Greg Powell from The Kalandan Foundation, the GYS was finally able to take a small group of young men on a Brumby Camp in the 2009-2010 financial year.

Keiran from the GYS and David Baird, a social work student from the University of Sydney, travelled by bus to Kalandan Station, not far from Bredbo. On board were five young men, a stack of food and heaps of excitement and anticipation for the upcoming camp.

Over a four day period, the young men worked not only their horse, but also their "emotional muscle", as Greg Powell describes the personal growth work sheets and group conversations that are undertaken each morning and night.

It was amazing to see how the young men went from being quite unsure around the horses to having the confidence to go for a lengthy ride through the Snowy Mountains high country.

There are many programs for young people out there, some with a lot of potential. Brumby Camp can, and does, produce excellent outcomes with "high risk" young people within a very short time. Greg Powell is a passionate and engaging master horseman. The young men on the Brumby Camp were enthralled by not only his ability with horses, but also his stories and take on life.

In early 2010, the GYS contributed to a story on *60 Minutes*, which profiled the Brumby Camp program and its focus on building self-esteem in young people from the GYS.

# GYS PROGRAMS: GIRL ZONE

Girl Zone at the Glebe Youth Service is a weekly program for girls only. The program provides a comfortable, safe space where young women can meet, socialise and participate in a range of activities and exercises.

The staff facilitating the Girl Zone program are all female and are dedicated to providing an environment that is valuable and safe for the young women who participate.

The program offers a diversity of activities and exercises which attempt to meet the changing needs of females aged between 10-24 years old. During the Girl Zone program, a nutritious, balanced meal is also cooked and enjoyed by the participants, which assists the young men develop skills and healthy eating habits.

Over the previous year, the Girl Zone program has increased in popularity amongst the young women who are connected to the Glebe Youth Service. The program changes each term, along with the focus of the activities changing to present an experience for the young women that is diverse, relevant, engaging and beneficial. Activities that have been implemented over the previous year have ranged from developing confidence, learning living skills, connecting with one's creative self and developing one's physical fitness and health.


The young women and staff have thoroughly enjoyed a range of activities and events including; hip hop workshops with Heaps Decent, boxing, drama workshops, cooking sessions, a night out to see the Bangarra Dance Theatre group at the Sydney Opera House, trips to movies, creative activities and health-focussed activities such as sexual health check days with the Sydney South West Area Health Service.

For the young women participating, which averaged between 20-25 individuals each week,

the Girl Zone program improved their self development, knowledge around health issues, fitness, self confidence, self worth and identity.

The success of the program has also resulted in positive media coverage. In the early part of the 2009-2010 financial year, Girl Zone was profiled on the national Indigenous current affairs program on SBS, *Living Black*.

Without a doubt the Girl Zone program is a very valuable initiative delivered by the Glebe Youth Service. The contributions of Youth Worker, Ainsley Warner, are invaluable to this program.

# GYS PROGRAMS: YOUNG PARENTS



The Inner West Young Parents Group (YPP) is a multi-agency housing program. Participating agencies include government and NGOs such as Community Services NSW, Housing NSW, SDN Children's Services, RPA Indigenous Health Workers, Glebe School's Community Centre, Elsie's Women's Refuge, Glebe's Young Parents Worker and Glebe Youth Service.

The YPP aims to house Glebe's young parents, with priority given to Indigenous young parents. In addition to housing, the referrals made to the YPP provide an integrated case plan. Once housed, this ensures clients are supported and receive case management assistance.

The ground work for the program has been laid in 2009-2010 and we look forward to reporting on outcomes in 2010-2011.

It is important to acknowledge Youth Worker, Ainsley Warner, for the hard work she has put into this program. In particular, the GYS would like acknowledge her strength and resilience in working in a complex and challenging multiagency partnership.

The GYS commends Ainsley for advocating for the those young parents living in Glebe who stand to benefit the most from the program.

# GYS PROGRAMS: EDUCATION PATHWAYS

The Glebe Pathways Program began in Term 4 of 2009 on Monday, 19 October, 2009. It has thus been operational for nearly one year.

The Glebe Pathways Project provides young people aged between 12-16 years old with a student-centred learning environment.

Employing "big picture" principals, the program seeks to instill a love of learning in young people for whom mainstream schooling has ceased to be a productive option.

Here students are guided towards conventional curriculum via the identification and pursuit of their own real world passions. Such passions are ignited inside the classroom and in the community settings where young people interact.

The Glebe Pathways Program is a collaboration between the Glebe Youth Service, Sydney Secondary College, the University of Sydney, Big Picture Australia and Save the Children Australia. The program believes that all young people have the right to a fulfilling education and the program is directed towards this goal.

In the first year of operation, the room in which the learning takes place at the GYS has been painted, resourced with textbooks and computers, as well as decorated, so that it now looks and feels like a productive learning environment.

Core personnel from the Department of Education and Training have remained stable, with Caterina DiGirolamo, Janelle Scott and Jan Flanagan staying with the program. In Term 2, Joe Angert joined the team.

A new position was created and funded by Save the Children Australia and this has brought Gareth Jenkins into the program to offer Outreach support. This new position links the school with the staff at the GYS, supplements teaching staff when required, provides casework support to students and organises some curricular and extracurricular activities.

Program delivery has gone through a steady evolution as teaching staff adapt aspects of the "big picture" model to the present students and conditions, as well as invent strategies of their own to engage students.

Term 3 has seen the first student exhibition. This was a chance for students to display the work they had been doing in the program and was attended by relevant project stakeholders and the students' significant others.

Furthermore, Term 3 has seen the introduction of additional structure into the learning environment, with each student mapping out a Learning Plan every two weeks. This involves students being given or nominating a series of tasks in key curriculum areas of maths, science, English, history, geography, visual arts and sport.

Each day, students select a task to concentrate on. In this way, students are required to complete two tasks from each subject area in each two week period. Each day they record the work they have completed in their diary. This system gives both teaching staff and students a tangible record of learning completed and moreover, achieved.

In addition to these plans, each student has participated in an official Learning Plan meeting with Gareth, Caterina, Doreen Wilson (Principal of Sydney Secondary College), Christine Burke (School Counsellor) and a parent or carer in the last two weeks of term to look back over work done and to plan learning in Term 4.

In Term 4, two students are on track to sit the School Certificate. Two further students are on track to finish the program with a Life Skills School Certificate that will allow them entry to a number of TAFE courses where they can continue their education, and build upon the skills they have learnt in this project.

Kathy Farrawell is currently working with students to create art works around the idea of "Unsung Heros". Such artworks will be submitted for exhibition in *Koori Art Expressions* at the Australian Museum from 2 December onwards.

A circus program will go ahead in the fourth week of Term 4, which is funded by Save the Children Australia. An Indigenous circus performer with experience doing workshops with "at risk" young people will run the program at the GYS. This circus performer will also speak to the young people in the program about the work she has done with Indigenous young people, including those who's mothers are in jail.

Save the Children Australia has also made funds available for a school camp at the end of Term 4. This will involve educational and adventure activities and will end the year on an enjoyable and enlightening note.

# COMMUNITY EVENTS AT THE GYS

## CINEMA NIGHT

In December 2009, we held the 2nd Annual GYS Film and Fun Night. The night aims to showcase the creativity of local young people who access programs run by the GYS. The night presents an artistic avenue for local young people to express their talents and personal experiences.

The newly formed trio of local youths, the Str8 Ballaz, who have been gaining popularity in the local club scene, were the headline act on the night. A quote from the lead singer of the St8 Ballaz, Kieren White, sums up the importance of the event in the lives of the young people in Glebe: "Music allows us to express ourselves... [and] what it's like to grow up in Glebe."

We also showed a number of short films. Some of these were made at the Glebe Youth Service with Vinnie MacManus from Short Black Films.

Alongside music and films, the event also involved: games, aerosol art, raffles and an auction. The highlight of these events was the paper plane competitions which saw a plane made by one young person, Jerome, fly a good 30 metres, which was at least 20 metres further than the nearest competitor. All the while there were wild cheers from the onlooking crowd.

The night was organised by a dedicated team of staff, volunteers and service partners. In particular, the GYS would like to thank the volunteers who put in a great deal of time planning the event and also working on the night.

The night was well-attended by young people, families and the wider community. Without a doubt, the night was a great success and we look forward to holding the event again in 2010.

Into its third year, the annual night has attracted attention from Glebe and inner west suburbs.

### NAIDOC

The GYS hosted another event called the Corroboree Night, which was held on Saturday, 10 July. Members from the Management Committee pre-cooked a wide range of meals that were served at the event.

There was a variety of performances on the night including a hip hop and break dancing performance that involved audience participation, a well-known Indigenous music group called, The Black Turtles, and a performance from our very own Str8 Ballaz, who impressed onlookers with their new tracks. Vincent Buchanan from the Str8 Ballaz, also one of GYS's young people, was the sound technician for the event.

Approximately 100 people attended the event, including regular and new young people, many Indigenous Elders from the community, random passers-by, two Glebe Police Officers (Aboriginal Community Liaison Officer and Youth Liaison Officer) and the Glebe Youth Service Management Committee. It was a fantastic community event that left everyone with very positive feelings.

## **RECONCILIATION WEEK**

Fetina Lotoaniu, a former Glebe Youth Service client, approached staff about holding an event for Reconciliation Week at the service. We then collaborated on a funding submission for the event, which was successful, through City of Sydney's Quick Response Grants initiative. The event was a huge success, with approximately 120 members of the community attending

The anniversary of Reconciliation Week is significant to Indigenous communities. The knowledge of these dates and their significance is lacking in the wider community. The week is an opportunity, created by the Federal government, to address and discuss Reconciliation at both a national and local level.

The event brought together diverse groups of community members and fostered community development through dialogue, participation and inclusion. The event included talks by Indigenous Elders, arts and crafts, displays of traditional tools, as well as information regarding health, safety and personal development. The talks focused on educating the community about the significance of Reconciliation Week, along with Aboriginal and Torres Strait Islander culture and healing practices.

This event and its components are significant to the Glebe community and were an introduction to Aboriginal and Torres Strait Islander culture for non-Indigenous people through recognition and acknowledgement of the community. The event also furthered understandings of culture, identity, respect and healing among Indigenous members of the community.

We are hoping to run the event again in 2011.

# **VOLUNTEERS** AT THE GYS

The Glebe Youth Service greatly values the contributions that volunteers make to the service. As a small not-for-profit organisation, the GYS relies upon the support and services that are provided through volunteer workers from the local and surrounding communities.

The staff at the GYS are extremely grateful to those who give their valuable time to the service, for the presence of volunteers enriches the delivery of services greatly.

There are a range of ways in which volunteers can become involved with the service, with volunteers working on a number of programs implemented through the GYS. Over the previous year there has been numerous volunteers getting involved with the Drop In program, the After Dark program, regular Holiday Programs and community events, such as the GYS Film and Music Night.

Many of the volunteers are from the local Glebe community. The service also receives interest from students at the University of Sydney, with connections being made over the past year with Australian Red Cross volunteers, the University of Sydney and the GYS.

Following an initial induction, the volunteers working at the GYS, are presented with the opportunity to experience:

- Engaging with the young people who use the service during the Drop In program, as well as the After Dark program;
- Cooking duties. Every afternoon we cook a meal for the young people. Volunteers are encouraged to help with the cooking as well as serving the meals to the young people;

 Within the Drop In program, activities are often presented to the young people, such as painting and drawing, basketball, table tennis, watching movies, using the internet as well as using the music studio.

If you possess a particular skill, for example music or art-related, the staff at the GYS are very open to hearing any suggestions or discussing any possible activities that could be incorporated into the already existing programs.

The GYS currently has over forty registered volunteers. We are looking to continue and expand our volunteer program in 2010-2011.

# GOVERNANCE AT THE GYS

## MANAGEMENT COMMITTEE

In the 2010-2011 financial year, the Management Committee is committed to developing and implementing a strategic plan that will improve service delivery for clients, thus enabling the GYS to further realise its objectives. The Management Committee is also focussed on fostering current partnerships, whilst exploring alternative funding sources.

Regarding membership, the Management Committee of the Glebe Youth Service must consist of a minimum of four and a maximum of eleven elected members, including a Chairperson, Vice Chairperson, Secretary and Treasurer. The Management Committee is elected at each AGM. To be eligible for election to the Management Committee, a person must have been a member of the GYS for at least three months immediately prior to their election.

The Management Committee may also choose to appoint a representative of any government agency or other organisation that provides funding to the GYS as an ex officio member.

Meetings with the Management Committee are held monthly. The Coordinator attends these meetings, provides advice and seeks guidance about operational issues affecting the GYS.

As of June 2010, current Management Committee members of the GYS are:

### **SVEN KNUTSEN**

In 1991, Sven joined the GYS Management Committee. He has been Chair for fifteen of the last sixteen years. Sven is the Director of his own IT consultancy company, Meerkat Computer Services. Previously, Sven worked for theatre companies and venues throughout Australia. Sven retired from the Arts in 1995 to pursue an ambition to run his own business full-time. Sven is also the resident percussionist with the funk punk, blues and jazz band the Exploding Happiness since 1993.

### HILARY CHESWORTH

Hilary has been Treasurer for the past three years. She is employed as Administrator at Redfern Legal Centre, and has previously worked in administrative roles in other community organisations. Patrick worked in uni finance area for over fifteen years. He currently works as solicitor in Darlington at Peter Murphy & Associates. He has over twenty five years experience with sporting administration. Patrick is currently Treasurer of Sydney University Sport and Fitness, as well as President and Coach at the Syd Uni Boxing Club. In 2010, Patrick was cocoach of the Sydney Uni Women's Rugby.
